

**PITT COUNTY BOARD OF COMMISSIONERS
GREENVILLE, NORTH CAROLINA
NOVEMBER 16, 1998**

The Pitt County Board of Commissioners met in a regular session meeting on Monday, November 16, 1998, at 9:00 a.m. in the Commissioners' Auditorium, Pitt County Office Building, Greenville, North Carolina with the following commissioners present:

Call to Order by Chairman Dews.

Prayer by Commissioner Warren.

Pledge by Commissioner Owens.

Approval of Agenda

Commissioner James asked to add an item on tobacco as item #8. Commissioner Johnson said that it was his understanding that according to process that when Ms. Warren vacates her position, the Board is supposed to notify the Democratic party. He requested the Board discuss writing a letter to the Democratic party for recommendation from Executive Committee for Commissioner Warren's vacancy.

UPON MOTION by Commissioner Johnson, seconded by Commissioner James, the Board voted unanimously to approve the agenda as amended.

Approval of Minutes

Chairman Dews asked for approval of the minutes from October 19 and November 2, meetings.

UPON MOTION by Commissioner Bright, seconded by Commissioner James, the Board voted unanimously to approve the minutes from October 19 and November 2, 1998.

Public Addresses to the Board

Commissioner-elect Glenn Bowen said that the Board should not go to the Executive Committee of the Democratic Party until there is a resignation and vacancy according to the law. Ms. Burgdorff stated that the Board would not be able to move forward on the recommendation until a vacancy is made, but they could ask for a recommendation from the party.

ITEMS FOR REPORT

Manager's Report - Tom Robinson

1. Mr. Robinson stated that the first quarterly sales tax figures including the new census figures had been received and are \$584,000 over last year's figure. He stated that this is a 16.25% increase over last year's receipts. He stated that the County should have a \$1.9 million increase for the year and that these funds were not budgeted. Commissioner James asked how much of these funds would go to the schools. Mr. Robinson responded that thirty-five percent of the funds would go to the schools. He stated that the Schools will have to reimburse the County for their part of the census.
2. Judy Tart will take the oath of office for the Register of Deeds at 8:00 a.m. on Wednesday at the Register of Deeds office.
3. Mr. Robinson asked Mr. James Rhodes, Planning Director, to address the request for a transportation committee combined with the Global TransPark combined transportation committee to help coordinate projects in the region. James Rhodes stated that Nancy Stallings has helped coordinate these types of groups in other areas. Mr. Rhodes said he thought the County had done a good job in the past on the transportation committee, but that Ms. Stallings had suggested that more people need to be brought into the group. Mr. Rhodes said that the County Commissioners do serve the County as a whole. He noted that the committee being discussed would include members from the Chamber of Commerce, Development Commission and the ten or more municipalities. He suggested the Board consider this over the next few weeks. Mr. Rhodes was concerned with the number of people that would be on the committee. He informed the Board that he would be giving a Transportation priorities report at the next meeting and asked the Board to wait on considering this transportation committee until the next Board meeting. Commissioner Bright said that Nancy Stallings, Executive Director of the Global TransPark Foundation was sent as a messenger from the Foundation to express that the County needs to have a broader base. Commissioner Gaskins suggested that the Board follow Mr. Rhodes recommendation and study the need further. Mr. Rhodes said that this committee would have some impact on the highways which run into and out of the County but would most directly effect what is inside the County.

Commissioner Moore arrived.

Commissioner James said that the County needs a bypass to go out towards Grifton. Commissioner James said there are a lot of roads that need help in Pitt County. Mr. Rhodes said there will be a report on these transportation issues at the next meeting. Commissioner Bright said that regional interest and involvement is what is needed.

Commissioner Savage arrived.

Chairman Dews said that it seems that every time the County makes some progress on a road, the funding is cut back. Commissioner Gaskins suggested a highway commissioner should also be present when this is considered.

Monthly Financial Report - Melonie Bryan, Director of Financial Services

Ms. Bryan reported that the County had received the \$15 million from Pitt County Memorial Hospital. She said the revenues are ahead by \$1 million even without the \$15 million. Ms. Bryan was asked if any of these funds were going to be spent. She stated that a portion of the interest earned will be used but the principle is not scheduled to be used. She stated that \$1.6 million is budgeted this year for interest earnings. Mr. Robinson stated that Ms. Bryan's staff will complete a cash flow analysis to determine where funds are needed and how much should be invested.

ITEMS FOR DECISION

Incorporation of the Region Q Workforce Development Board

Dr. Edgar Boyd, Pitt Community College introduced Lee Armstrong UNX, Carlton Hardee, John Carroll, and Sam Carson. He explained that the Workforce Development Board needed to adapt to the changing times. He said with the workforce reinvestment (redevelopment) act, they need to make some changes in the way they operate. He stated that they are requesting assistance from the Board of County Commissioners of each of the counties to reincorporate as a private corporation with 501C3 status.

Dr. Boyd said that the Mid-East Commission staff administers the funds and with this transfer they would then be tax-exempt. He stated that they would also be able to apply for and receive grant and foundation funds, as well as, charge fees for services. He stated there would be no change in the current board or staff but that the Boards of Commissioners would be asked to reappoint their board members. Dr. Boyd said there would be some legal counsel expense and a minimal filing fee of \$50.00. Dr. Boyd said they have the proposed articles of incorporation already written. The counties of Beaufort, Hertford, and Bertie have already approved the change. Commissioner Savage said he would be supportive of this request. Commissioner James also offered his support. Dr. Boyd said it would also enable them to received private monies. Commissioner Warren stated that this sounds like it would be an advantage to Pitt County. Mr. Bulow stated that he serves on the Workforce Development Board for Region Q and has read the by-laws.

UPON MOTION by Commissioner Savage, seconded by Commissioner James, the Board voted unanimously to approve the request to allow the Region Q Workforce Development Board to transfer their organization to a 501C3 status contingent upon the new Board of County Commissioner's review of the by-laws.

Eastern Pines Water Corporation - Year 2000 Water System Improvements - Glenn Hardee, Eastern Pines Water and Ron Sessoms, Rivers and Associates

Mr. James Rhodes prefaced the presentation by reviewing that the Eastern Pines Water Corporation is considering a twenty-seven mile expansion that will serve 230 new customers. It will require six and eight inch water mains. Mr. Rhodes pointed out on the map, the plans for the extension of water lines. He stated that they would be serving customers that are not already receiving water or are having problems with their water supply.

Mr. Glenn Hardee, President of Eastern Pines Water Corporation, informed the Board that they would like the Board's support on a \$1,800,000 loan applied for by the non-profit water corporation for the expansion plans for water lines. He said the Planning Department has already approved their plans.

UPON MOTION by Commissioner Gaskins, seconded by Commissioner Savage, to support the loan application for \$1.8 million and certify that the proposed Eastern Pines Water Corporation water system is consistent and compatible with the comprehensive water and sewer plan of Pitt County.

Mr. Hardee stated that they were working with other water corporations and did not wish to hurt any other entity by their expansion. The cost per customer is \$3,000 to \$5,000. Commissioner Johnson stated that Eastern Pines has worked very closely to provide water to the community. He said that each of the different corporations has different circumstances.

Commissioner Bright asked about Littlefield Road and if this expansion included Littlefield Road? Mr. Rhodes stated that the Town of Ayden had plans to put water on Littlefield Road and that the bids are out on that project. Mr. Ed Booth, Ayden Town Manager, shared their plans to put in water and sewer. He stated their plans go down Weyerhauser Road towards Grifton and that they are going in that direction because Grifton does not have the capability to provide water. The entire Littlefield Road will be served with water. Mr. Booth said that they are meeting with all the interested parties to establish lines and boundaries for water and sewer. Commissioner James noted that there had been problems with cities and towns working together on sewer. He expressed his support of this proposal. Mr. Hardee stated that there are so many areas in the County that are in need of this service and they could redirect, if necessary, so there would be very little overlap in lines. Mr. Robinson said that Mr. Hardee told him that they could only get the money if there are no conflicts. Mr. Rhodes said there would be one mile or less or overlap. The Chairman called for a vote on the motion which was unanimous. The motion was approved.

Sheppard Library Interlocal Agreement - JoAnne Burgdorff, County Attorney

Ms. Burgdorff stated that this Sheppard Memorial Interlocal Agreement clarifies the responsibilities agreed to by each entity.

UPON MOTION by Commissioner Johnson, seconded by Commissioner Moore, the Board voted to approve the five year interlocal agreement for Sheppard Memorial Library.

Interlocal Agreement for Fiber Optic Cable - JoAnne Burgdorff

Ms. Burgdorff stated that the Interlocal Agreement for Fiber Optic Cable has been revised numerous times. She stated that the staff was asking for authority for the Manager to sign the contract. The agreement is between East Carolina University, City of Greenville, Pitt County Memorial Hospital, Greenville Utilities and Pitt County for the sharing of the costs for installation of fiber optic cable to link all entities. Mr. Mike Taylor stated that this project has already been budgeted and the Board has previously approved the project. Commissioner Savage said the County should have required the Hospital and Medical School to pay for easement where they ran their

lines. Mike Taylor said that this line runs on Greenville Utilities Commission's right-of-way, except where it breaks off to come to the County Office Building for the services. He stated that each entity will pay equal cost.

UPON MOTION by Commissioner James, seconded by Commissioner Savage, the Board voted unanimously to authorize the County Manager to sign the Interlocal Agreement for Fiber Optic Cable.

Pitt Community College Bonds

UPON MOTION by Commissioner Owens, seconded by Commissioner Savage, to adopt the resolution authorizing the proposed issuance and establishment of a public hearing to be held during the regular meeting on December 7, 1998 for the Pitt Community College Bonds. Commissioner Owens said that the intent of the motion was to permit them to move forward with the completion of their second floor of the Student Services building. Commissioner James said they need parking areas. Commissioner James said they have a very valuable piece of land that the County can negotiate with them. Commissioner James said he is committed to the \$500,000 but not the \$1.5 million because it will cost the County \$110,000 annually. The other option would cost \$30,000 per year. Commissioner James said if the Community College wants to move forward with this then they will be willing to negotiate on the land.

Commissioner Bright offered a substitute to the original motion to authorize the Community College to complete the second floor of the Student Services Building. Commissioner Owens said that the intent of his motion was to include the completion of the Student Services Building, so Commissioner Bright withdrew his substitute motion. Commissioner Owens restated his motion for the Board's approval. Ms. Bryan explained that the \$1.5 million can be changed if necessary. The motion passed unanimously.

A regular meeting of the Board of Commissioners for the County of Pitt, North Carolina was held in the Commissioners' Auditorium, Pitt County Office Building, Greenville, North Carolina, the regular meeting, at 9:00 a.m. on November 16, 1998.

Present: Chairman Kenneth K. Dews, presiding and Commissioners Ed Bright, Jeff Savage, Tom Johnson, Mark Owens, Charles Gaskins, Eugene James, Farney Moore and Edith Warren.

Absent: Commissioners (none)

Also Present: Susan J. banks, Clerk; Melonie T. Bryan, Finance Officer; Tom Robinson, Manager; John Bulow, Asst. Manager and JoAnne Burgdorff, Attorney.

Commissioner Owens introduced the following resolution authorizing bonds which was read:

**RESOLUTION MAKING CERTAIN FINDINGS, RATIFYING THE

BONDS AND COMMUNITY COLLEGE BONDS OF THE COUNTY

BE IT RESOLVED by the Board of Commissioners (the "Board") of the County of Pitt, North Carolina (the "County"):

Section 1. The Board does hereby find and determine as follows:

- (a) Preliminary analysis has been completed to demonstrate the need for refunding all or a portion of the County's outstanding Community College Bonds, Series 1992, dated June 1, 1992.
- (b) Preliminary analysis has been completed to demonstrate the need for issuing bonds to improve the facilities, the renovation and expansion of the student services building, the acquisition of land for a law enforcement training facility and the acquisition of any other necessary land and rights of way.
- (c) The annual audits of the County show the County to be in strict compliance with debt management policies and that the budgetary and fiscal management policies are in compliance with law.

Section 2. The prior filing by the County of an application of the County with the North Carolina Local Government Commission for approval of the issuance of not to exceed \$8,800,000 Community College Refunding Bonds and approval of the issuance of not to exceed \$1,500,000 Community College Bonds of the County is hereby ratified, approved and confirmed.

Section 3. The law firm of Poyner & Spruill, L.L.P. is hereby appointed to serve, but solely at the pleasure of the Board, as bond counsel to the County in connection with the issuance of the Community College Refunding Bonds and the Community College Bonds.

Section 4. Wachovia Capital Markets, Inc., is hereby appointed to serve, but solely at the pleasure of the Board, as financial advisor to the County in connection with the issuance of the Community College Refunding Bonds.

Section 5. This resolution shall take effect immediately upon its passage.

Thereupon the resolution entitled "RESOLUTION MAKING CERTAIN FINDINGS, RATIFYING THE PRIOR FILING OF AN APPLICATION WITH THE LOCAL GOVERNMENT COMMISSION AND APPOINTING BOND COUNSEL AND A FINANCIAL ADVISOR IN CONNECTION WITH THE PROPOSED

ISSUANCE OF COMMUNITY COLLEGE REFUNDING BONDS AND COMMUNITY COLLEGE BONDS OF THE COUNTY” was passed by the following vote:

Thereupon Commissioner Owens introduced the following orders authorizing bonds which were read:

ORDER AUTHORIZING \$8,800,000 COMMUNITY COLLEGE REFUNDING BONDS

BE ORDERED by the Board of Commissioners for the County of Pitt, North Carolina:

1. That pursuant to the Local Government Bond Act, as amended, the County of Pitt, North Carolina, is hereby authorized to contract a debt, in addition to any and all other debt which said County may now or hereafter have power and authority to contract, and in evidence thereof to issue Community College Refunding Bonds in an aggregate principal amount not exceeding \$8,800,000 for the purpose of providing funds, with any other available funds, for refunding all or a portion of the County’s outstanding Community College Bonds, Series 1992, dated June 1, 1992, and paying certain expenses related thereto.
2. That taxes shall be levied in an amount sufficient to pay the principal of and the interest on said bonds.
3. That a sworn statement of debt of said County has been filed with the Clerk to the Board and is open to public inspection.
4. That this order shall take effect upon adoption.

ORDER AUTHORIZING \$1,500,000 COMMUNITY COLLEGE BONDS

BE IT ORDERED by the Board of Commissioners for the County of Pitt, North Carolina:

1. That pursuant to The Local Government Bond Act, as amended, the County of Pitt, North Carolina, is hereby authorized to contract a debt, in addition to any and all other debt which said County may now or hereafter have power and authority to contract, and in evidence thereof to issue Community College Bonds in an aggregate principal amount not exceeding \$1,500,000 for the purpose of providing funds, with any other available funds, for improving the facilities of Pitt Community College, including, without limitation, the construction of parking facilities, the renovation and expansion of the student services building, the acquisition of land for a law enforcement training facility and the acquisition of any other necessary land and rights of way.
2. That taxes shall be levied in an amount sufficient to pay the principal of and the interest on said bonds.
3. That a sworn statement of debt of the County has been filed with the Clerk to the Board and is open to public inspection.
4. That this order shall take effect 30 days after its publication following adopt, unless it is petitioned to a vote of the people within 30 days after the date of its publication as introduced as provided in G.S. 159-60, in which event it will take effect when approved by the voters of said County at a referendum as provided in said Act.
5. This order is adopted pursuant to the provision of G.S. 159-49, which authorized issuance of bonds without a vote of the people for purposes specified therein in an amount not exceeding two-thirds of the amount by which the outstanding indebtedness of the City has been reduced in the preceding fiscal year.

The Board of Commissioners whereupon designated the Director of Financial Services to make and file with the Clerk to the Board the sworn statement of debt of the County which is required by The Local Government Bond Act, as amended, to be filed after the bond order has been introduced and before the public hearing thereon.

Thereupon, the Director of Financial Services filed with the Clerk to the Board, in the presence of the Board of Commissioners, the sworn statement of debt as so required.

Thereupon, the order entitled "ORDER AUTHORIZING \$8,800,000 COMMUNITY COLLEGE REFUNDING BONDS" was passed upon introduction by the following vote:

Ayes: Unanimous.

Noes: None.

Thereupon, the order entitled "ORDER AUTHORIZING \$1,500,000 COMMUNITY COLLEGE BONDS" was passed upon introduction by the following vote:

Ayes: Unanimous.

Noes: None.

On motion duly made, seconded and carried, the Board of Commissioners fixed 9:00 a.m. on December 7, 1998, in the Commissioners' Auditorium, Pitt County Office Building, Greenville, North Carolina, as the hour, day and place for the public hearing upon the foregoing orders and directed the Clerk to the Board to publish said orders, as required by The Local Government Bond Act, as amended, once in The Daily Reflector not later than the sixth day before said date.

Mr. Raymond Reddrick asked the Board to reconsider the water needs for Emorywood Subdivision.

Mental Health Budget Amendments - Darlene Hunnicutt

Ms. Hunnicutt stated that the request from the Mental Health Center was to approve the concept and budget changes which were discussed at the joint meeting of the Mental Health Area Board and the Board of Commissioners. The purpose was to adjust the budget's ending balance and it incorporates all the changes presented to the Board in October.

UPON MOTION by Commissioner Savage, seconded by Commissioner Bright, the Board voted unanimously to adopt a new total budget figure of \$16,092,267.00 for the Pitt County Mental Health, Developmental Disabilities, and Substance Abuse Program. Mr. Robinson said that they are adjusting their budget and that there should be some overage at the end of the year.

Miscellaneous

Tobacco Matters

Commissioner James said he was concerned about the agreement that had been signed by North Carolina's Attorney General and six others concerning the tobacco settlement. He said that North Carolina's share is an estimated \$135 million per year. Commissioner James said that this money would be coming to the North Carolina Department of Agriculture and that Pitt County should get involved so it would receive its fair share. He suggested the Board contact the Governor, Secretary Graham, and the Attorney General. He suggested that the Board ask Chairman Dews to take a leadership role on this tobacco situation. He stated that this change will raise the price of cigarette packs about 35 cents. Commissioner Gaskins asked about the Farm Bureaus' role in this situation? Commissioner James said that they are working on it.

UPON MOTION by Commissioner James, seconded by Commissioner Savage, the Board voted unanimously to instruct Chairman Dews to take the lead role and contact Governor Hunt and other leadership in Raleigh on what steps the County should take in order to assure that Pitt County gets the fair share of money for tobacco growers, lot holders and Medicaid funding.

Chairman Dews said that Pitt County should be able to get top dollar and will need to be forceful to get that money.

Board Appointment

Commissioner Johnson stated that in order to get the procedure in motion for a replacement for Commissioner Edith Warren, who was elected to the House of Representatives, the Board needs to make a request to the Democratic Party for a recommendation to fill Commissioner Warren's vacancy.

Commissioner Johnson offered a motion for the Board to send a written request to the Democratic Party asking for their recommendation to fill Commissioner Edith Warren's position. Commissioner Savage seconded the motion. Chairman Dews explained the law requires the Board of Commissioners to allow the political party to make a recommendation for a replacement on the Board when a vacancy occurs.

Ms. Burgdorff stated that the Board is required to request the Democratic Executive Committee to make a recommendation to the Board of County Commissioners for a replacement when there is a vacancy. She stated that since there is a vacancy which will occur, once Ms. Warren resigns to take the new position, then there is no problem with requesting the recommendation. Ms. Burgdorff stated that as long as the replacement is not appointed prior to Commissioner Warren's resignation, then the Board would be within the law. She stated that there is no harm in doing this ahead of time.

Mr. Glenn Bowen, Commissioner-elect, stated he had talked with Patrice Roesler at the North Carolina Association of County Commissioners and Johnnie McClain at the Board of Elections, both who stated that it had to be done after the resignation of the current member. Ms. Burgdorff stated that she had attended a meeting at the Institute of Government, where they had discussed this particular issue and there is no time frame in the General Statute given to request the recommendation. Commissioner James said that the Board would be doing something that does not need to be done at this time.

Chairman Dews called for a vote on the motion to request a recommendation from the Democratic Party for Commissioner Warren's replacement. The Board voted unanimously in favor of the motion.

Closed Session

Ms. JoAnne Burgdorff read the following NCGS 143-318.11(a)(4) to discuss matters in relation to the location or expansion of industries or other businesses in the are served by the public body.

UPON MOTION by Commissioner James, seconded by Commissioner Moore, the Board voted to go into closed session following the break.

UPON MOTION by Commissioner Savage, seconded by Commissioner James, the Board voted unanimously to return to open session.

UPON MOTION by Commissioner James, seconded by Commissioner Bright, the Board voted unanimously to adjourn this meeting at 11:05 a.m.
