PLEASE READ AGREEMENT BELOW REGARDING SCHOOL FACILITIES LIABILITIES

AGREEMENT

Section 115-133 of the General Statutes of North Carolina, provides, in pertinent part, that no liability shall attach to any Board of Education individually or collectively for personal injury suffered by reason of the use of school property. It is understood and agreed by and between the parties of this contract that under this Statute and under the doctrine of governmental immunity the Pitt County Board of Education is exempt from any and all liability for any damage or injury to person or property caused by or resulting from any cause of happening whatsoever. It is further understood and agreed by and between the parties to this contract that the use of school facilities shall have full and complete responsibility for the proper care and use of such facilities and shall be liable to the Pitt County Board of Education for any damages to such school facilities resulting from any action of the user or the user's agent, employees, members of the invitees during the period of use of such facilities by users as approved by the Pitt County Board of Education. The user of school facilities under and pursuant to the terms of this contract hereby agree to indemnify and hold the Pitt County Board of Education harmless on account of any property damage or personal injury resulting from the use of said school facilities by user except to the extent otherwise provided by law. It is understood that upon the signing of the contract all parties involved in stated organization have read and understand the policy entitled "Rules and Regulations for Use of Facilities". It is further understood that the organization or individual agree to fees and charges as stated and will be responsible to pay for any damages during the use of facility. **It is also understood that no alcoholic beverages or smoking is allowed on the school premises.**
