The Pitt County Technical Review Committee (TRC) met in regular session on January 29, 2025, at 9:00 a.m. in the Planning Conference Room of the Development Services Building, 1717 West 5th Street, Greenville, North Carolina, and on WebEx.

APPROVAL OF THE NOVEMBER 27, 2024 MINUTES

UPON MOTION by Mr. Gooby, seconded by Mr. Earls, the Pitt County Technical Review Committee voted unanimously via roll call vote to approve the minutes of the December 11, 2024 TRC Meeting.

SOIL EROSION AND SEDIMENTATION CONTROL PLANS

MONTEVALLO SECTION 1, PHASE 3: Located off Montevallo Lane, West of its intersection with Seven Iron Drive in the Ayden Township.

Site Data: 10.5 Acres, 40 Lots, 10.5 Disturbed Acres

CONDITIONS AND REQUIREMENTS

[Pitt County Planning]

1. Concrete washout location is not shown.
2. Show any stockpile/borrow locations.
3. Legend is missing.
4. FES1 & P4 aren't within the Limits of Disturbance.

[NCDOT]

5. With no access to SR 1723 required in this phase of Montevallo, no driveway permit will be required. I've attached the original site layout; a driveway permit will be required before the second driveway entrance ties into SR 1723.
6. The original site review shows this site at 193 lots. The original requirements for the driveways were to have right turn lanes into the site. Once the site exceeds the 193 lots (as shown on the original layout), roadway improvements may be required for left turn lanes going into the development.
7. Any other work performed within the NCDOT ROW will require encroachment agreements.

[General Comments]

[Pitt County Planning]

- Silt fence and additional check dams may be required if a need is shown.

[Pitt County Soil and Water]

- Soils: (*Pitt County Soil Survey - Sheet No. 68*)
(Soil Types: (Os - Osier) and (WaB - Wagram)).
- Existing subsurface drainage is on site.
- Soils are prime farmland or have statewide importance for farming. Development will remove the site from agricultural production.
- The adjacent drainage laterals should be cleaned out to their original bottom for improved drainage.
- There is a record of sub-surface drain tile. Please see the attached drain tile map.


