Ms. Sparling mentioned Public Health is doing the community health needs assessments and they are receiving feedback from the community and would be a resource for the HRC.

Mr. Seijo mentioned there are a few environmental groups around Pitt County and the HRC could possibly work with them. He also mentioned maybe getting involved in registering citizens

to vote and encouraging people to vote. Chairwoman Williams stated she would look into it to make sure it is okay for the HRC to be involved.

Mr. Dawson mentioned having a community clean up day, maybe at a school first and branch out after that.

Mr. Staton mentioned he went to the Jackie Robinson ceremony and encouraged the members to check them out.

Mayor Wilson mentioned Bethel will be having fireworks on July 1st event will start at 6:30 at 7459 Mainstreet Bethel NC
